MEMORANDUM

This has got the reference to the Order issued by the Special Secretary, Transport, Drugs and Equipment Branch, Dept.of H&FW, Govt.of West Bengal vide Memo No. : H/TDE/1104/5S-34/2014 dated 31.10.2014. All the Chief Medical Officers of the District, concerned MSVPs of the Medical College & Hospital and Superintendents (for ADMH, LDVH & SNPH, Kolkata only) are requested to purchase the necessary consumables e.g., Syringe (5 ml), Butterfly Syringe (2 ml), Vials (5 ml), Disposable Gloves (6"/6.5"/7"), Cotton, Ethanol Rectified Spirit (95%), Microtips (2-200 µl), Hypochlorite Solution, Colour Coded Plastics (Black, Yellow, Blue) etc.for usage at ICTCs (Stand-Alone/Mobile) and Safe Delivery Kits (for Stand-Alone/Mobile/Facility-integrated/PPP-mode ICTCs) under their jurisdiction as per requirements from the fund lying with them under the head of equipments. All procurement should be made in line with procuring hospital supply of the similar items.

Procurement of all necessary consumables for Stand-Alone and Mobile ICTCs will be ensured as per Annexure-I. Procurement of Safe Delivery Kits for Facility-Integrated ones and those ICTCs under Public-Private Partnership mode will be ensured as per Annexure-II.
