Minutes of the HIV-TB Coordination & Performance Review Meeting of DAPCU Kolkata was held on 29th April, 2015 at the Conference Room of WBSAPCS:

The Meeting was chaired by Dr. Nishi Kanta Haldar, Joint Director (BSD) and he informed all members the utility of the above meeting. District Assistant (M&E) presented the power point presentation regarding performance review of all facilities of Kolkata District.

The following points are discussed in the meeting:-

1. DPM, DAPCU Kolkata discussed regarding target & achievement of ICTC component for the FY 2014-15. She informed regarding the performance of achievement of ICTC testing according to the district target which is less than 80% to be improved more in the FY 2015-16.

JD-BSD instructed all the ICTC/ICTC ANC counselors to perform better in this financial year.

2. Blood Bank:

All the Blood Bank Counselor informed that previously a donor having low HIV positivity screening value at blood bank was not allowed for counseling. But after the completion of induction training of blood bank counselor, they came to know that all donors having low to high HIV positivity screening value must come for counseling at blood bank.

3. STI:

DD-STI informed all the STI counselor that without accompanied referral the referral status would not be increased. He also instructed that if any STI counselor was unable to attend the DAPCU Monthly Meeting, without prior intimation show cause may be issued.

4. ART:

SMO, SSKM ART Centre informed that the LFU case has increased due to patient of other states like Bihar, Jharkhand. They initially took the ART medicine and then went to his/her native place. JD-BSD instructed to all ART representatives to send the LFU list of other states to DAPCU Kolkata.

5. ICTC:

JD-BSD informed regarding WBFPT screening test which will be started at sub-centers of West Bengal very soon.

Administrative Issue: JD-BSD discussed regarding SOE/UC, decentralization of recruitment, contingency fund. He informed that the order of contingency fund has been send today.

He also informed that 10 Electronic Device Tablets will be procured for the ICTC & ICTC ANC units of 5 medical colleges in Kolkata as a pilot project.

According to JD-BSD a refrigerator van will be procured very soon for transportation of HIV test Kits within the ICTC facilities of Kolkata and outer districts.


JD-BSD also informed that now KIT-2 & KIT-3 will be procured by State and KIT-1 will be supplied by NACO.

PPTCT Consultant informed regarding using of DBS card and the new guideline for DBS testing and TLE for ANC mother. He also informed that SMS for stock position at Kolkata District is not received properly so requested all counselors to read out the guidelines carefully.

AD- (ICTC & M&E) informed all the STI counselors of Kolkata that STI reporting is very poor. He also informed that as per instruction of the Project Director, WBSAP&CS, a letter has been sent to all the MOIC, Blood Banks due to defaulter on SIMS reporting in time.

He discussed regarding "21 Digit PID Code for Stand Alone ICTC Clients". This unique code is to be used to identify the ICTC client at all level of testing at the Stand Alone ICTC. It is applicable for the clients who are attending in Stand Alone ICTCs since 1st May 2015 onwards.

The meeting ended with vote of thanks.
