The third fortnightly coordination meeting of TI, STI, CST and ICTC was held on 07.04.2015 at 3 p.m. at the Chamber of the Project Director/Dy.Project Director, WBSAP&CS Swasthya Bhawan, Kolkata-91. The same was convened by Dr. D. N. Goswami, Joint Director (TI) and the Chief Coordinator of TI, STI & CST Divisions, WBSAP&CS. The Dy.Secretary in Dept.of H&FW, Govt.of West Bengal and Dy.Project Director, WBSAP&CS chaired the said meeting.

The meeting begun with sharing the resolutions of the 2<sup>nd</sup> fortnightly meeting by the Chief Coordinator that was held on 17.03.15 and acceptance of the same by the house. After detailed discussion on different agenda items, the following resolutions were adopted :

- M & E Division, WBSAP&CS is yet to share data with the Chief Coordinator regarding districtwise linkage loss for better understanding of the same and further course of action in accordance to the same.
- As reported by DD (STI) the DSRC footfall had got improved in comparison to last month after issuance of the order relating to strengthening of referral-linkage that was issued by the Dy. Project Director, WBSAP&CS (Ref : OM ACS/IN-04-2015/1835 dtd.20.03.2015).

- JD (TI) reported that the issue of Pre-ART registration from TI NGOs at different ARTCs more or less no longer exists at the present moment.
- Private practitioners – both MBBS and quacks treating STI/RTI cases will be brought under the reporting coverage because a good number of cases are being treated by them that are not yet captured/tracked by state. It is proposed that Indian Medical Association (IMA) will be approached to provide necessary training on syndromic management of STI.
- JD (CST) reported that out of fifteen presently functional ARTCs in the state, nine ARTCs have shared the minutes of ART-CSC monthly coordination meetings. He was requested to further ensure the conduction of the coordination meetings on regular basis involving ICTCs, DSRCs, DAPCUs, DLNs, TI-NGOs to address linkage loss issues, missed out cases, LFU tracking etc. The sharing of the minutes with the Chief Coordinator alongwith the division concerned should also be ensured.
- Following DDG (STI/BTS/BSD), NACO's letter regarding identification of training institutes for conducting Integrated Training of ICTC, STI and ARTC Counsellors. Medical College, Kolkata and NBMC, Siliguri, Darjeeling will be approached. All concerned divisional heads are requested to submit the names of the Resource Persons to concerned division of NACO with a copy to the Chief Coordinator.

The next fortnightly coordination meeting has been scheduled on 23.04.15.

The meeting was concluded with vote of thanks to the Chair.
