Authorized representatives of SBTC shall draw samples of these kits from your warehouse and get them quality-tested at approved laboratory. If your samples pass quality test, you shall be issued a photocopy of the test-report by SBTC. You shall then supply these testing kits to us along with photocopy of the said test-report. Other terms and conditions of the CMS tender, including deduction of 2% testing charges shall remain applicable for this purchase order."
