- 2. Provide inputs to the National Programme through the various mechanisms available & encourage their peers to participate as well.
- 3. All Champions will undergo capacity building by NACO

Terms of Reference (TOR) of Community Champions

The Community Champions will bring the voice and needs of the community to the NACP & work with other stakeholders at the district level ,including District level networks ,CBOs & NGOs.

The champions role is voluntary, each champions will take up some of the following work in their districts, without any additional remuneration.

- 1. Strengthen the concept of "Community Championship" to include Community representatives in all aspects of program planning, implementation and monitoring.
- 2. Identify the Community needs and support CRG in advocating for their addressal with multiple stakeholders
- 3. Support SACS/TI in mobilizing KPs /PLHIVs for specific events (supported by SACS)
- 4. Engage with CBO/DLN on CSS related activity

5. Attend training programme as and when required under the Community Championship program.

Essential Criteria:-

1. Community member above 18yrs of age.

2. Belonging to KPs or PLHIVs or specific sub-groups (adolescent PLHIV, Youth, Women, Transmenetc)

3. Fluent in the local language of the local region.

Desirable Criteria:-

In addition, the following are desirable characteristics

1. Have a large network of peers

2. From the local district and state

3. Able to understand and Communicate the Community's needs

4. Is active within Community inititatives, is motivated to contribute to Community empowerment and ensurte Community participation in enhancing the NACP Programme.

5. Are not employed full-time within the NACP Programme (within TI,ARTCentresetc) to prevent conflict of interest.

Selection Methodology for the Community Champions

1. Nomination Process:-

SACS will release the EOI calling for nominations for community Champions.

- A) The Community networks ,CBOs ,and civil Society organisations as well as TI,LWS,ART can send their nominations of individuals
- B) Individuals can send in their self-nominations.
- C) Maximum age limit for Youth should be 25yrs.

2. Selection Process:-

The nominations/EOI/s will be listed and further ,collated by the SACS. The collated nominations are shared to the selection committee for finalization. The selection committee will do the final selection as per SOP developed for this by NACO
