**SANCTION ORDER**

Sanction is hereby accorded for a sum of Rs.37.52 Lakhs (Rupees thirty seven lakhs fifty two thousand only) in favour of the Director, IBTM&IH, Kolkata, MSVP of the Medical College & Hospital and Dy. CMOH-II of the Districts as per matrix given in the attached Annexure – I for procurement of Blood Bank Consumables during this current financial year. A tentative list of Consumables is attached herewith for convenience of all concerned.

The fund is being placed in the Bank Account of the Blood Banks in case of Medical College & Hospital and Dy. CMOH-II in case of the Districts.

Director, IBTM&IH will be the authority of procurement for the Blood Bank attached to IBTM&IH only.

The MSVP in consultation with the authority of their respective Blood Bank will arrange for the said procurement.

The Dy. CMOH-II of the Districts will arrange for the said procurement through DRS in consultation with the authorities of the Blood Banks under their jurisdiction.

Normally, the procurement is to be made from CMS approved vendor in case of CMS catalogue items. In case of Non-CAT items existing norms of procurement of the Govt. of West Bengal is to be followed.


The quarterly SOE & UC is to be submitted to the Project Director, WBSAP&CS as per existing norms. This has got the approval of the Project Director, WBSAP&CS in file no. ACS/2B-09-2010/Pt-I dtd. 06.01.2015.
