4. <u>Appointment of Auditor (Both Statutory & Internal)</u>: Engagement of M/s. Ashok Sen & Associate as the Internal Auditor for auditing the accounts of 8 RBTCs for the financial year 2014-15 at a consolidated Rs. 95.000/- (Rs. Ninety-five thousand only), was ratified by the members of the Governing Body.
